Election gives mandate for bold pro-family agenda.

After a historic election that displayed God's mercy on our nation, it's time to get to work turning election wins into policy wins.

With a historic election now behind us, I firmly believe the encouraging results are a display of God's mercy on our nation. Riding the coattails of Donald Trump winning the electoral college and popular vote, with a broad coalition of voters, Republicans took control of the U.S. Senate and retained their majority in the House.

2. Radically embracing abortion was not a winning issue for candidates, and the pro-life cause won important victories. Americans did not respond well to candidates, like Vice President Harris, who made abortion-on-demand their central focus, and voters overwhelmingly elected pro-life candidates across the nation and here in Kentucky. I praise the Lord that Florida, Nebraska, and South Dakota voted down radical

abortion proposals, keeping pro-life laws on the books in those states. But there is much work to do as 7 states still passed pro-abortion amendments.

3. The KY General Assembly has a mandate for a bold pro-family agenda, and we must capitalize on it! Voters are tired of the status-quo and want to see bold action. We can and must promote policies in the 2025 legislative session that will further cement Kentucky as a leading pro-family state.

But we must always remember that an election is not the finish line for those committed to God-honoring policy – it is just the beginning! We still have work to do, and the Lord has provided us with an opportunity to turn election wins into longer-term policy wins.

I know that you will join me in praying for God's continued favor and blessing on our great nation and Commonwealth. Thank you for showing love of your neighbors through your involvement this election season. Together, we can continue to serve Kentucky by strengthening families and the biblical values that make them strong!

A time for conviction: what the election should tell social conservatives about policy priorities.

OPINION: Nick Spencer on seizing the moment to push back on cultural madness in the Commonwealth.

In the closing days of the 2024 presidential campaign, now President-elect Trump and his team ran advertisements with the refrain “Kamala is for they/them, President Trump is for you.” The goal of this media campaign was seemingly to highlight Vice President Harris’ record on social issues pertaining specifically to transgenderism. Attention was given to Harris’ views on men being able to participate in women’s sports, giving taxpayer-funded gender surgeries to prisoners, and her general ideological alignment with the extremely progressive leadership of the LGBTQ moral revolution.

Only now, after the results have come in, is the sizable impact of that ad—and of socially conservative messaging in general—truly able to be measured. The result? The 2024 election cycle will stand as one of the clearest signals from the American electorate pushing back against cultural wokeness since the rise of the Moral Majority in the 1980s. Doing so in a strong, unambiguous manner is clearly desired by voters. More importantly, resolving to fight fiercely for cultural renewal according to biblical principles is the duty of every follower of Christ, especially those called to be God’s servants in Frankfort and in Washington (Rom. 13:4).

In their Voter Analysis of the 2024 electorate, Fox News asked voters, “Do you think support for transgender rights in government and society has gone too far, not gone far enough, or been about right?” In reply, a full 55% of respondents indicated that support for transgenderism by governing authorities had gone too far. Further, 83% of respondents indicated that the country ought to experience at least substantial change. Taking these two numbers together, it would be reasonable to conclude that the electorate’s views on social issues are trending in a more conservative direction. Whether this is attributable to COVID exposing the anti-Christian ideological indoctrination happening in government-run schools around the country, the Biden/Harris administration’s embrace of sexual revolutionaries that deny the goodness of God’s design for his image-bearers, or the invasion of DEI and other neo-Marxist thought into institutions of varying shape and size, governing authorities in the Commonwealth and the nation’s capital have been elected for the purpose of change. In seeking to enact that change, legislators and other officials need to look no further than Genesis 1:27 to find their first policy priority: recognize and defend the reality of gender’s immutable character and the goodness therein.

For countless decades, the sexual revolution’s message on gender has centered around two false and contradictory statements: masculinity in its true form is oppressive to women, and women must be permitted and encouraged to accomplish traditionally masculine tasks in order to be truly equal with men. Not only do these messages deny the inherent goodness of masculine and feminine

forms, they connect equality of persons with a subjective reality—degrees of accomplishment—rather than an objective quality of the image of God displayed in each human being. As a result, men who are told that their masculinity is evil and oppressive seek to escape it by acting and “becoming” feminine. Further, women who are told that the only way for them to be valued in society is through jettisoning their femininity have been pursuing harmful behaviors and medical treatments designed to “make” them more masculine. The well-being of society, and the promotion of good with which governing authorities are charged by God, begins with protecting and promoting proper visions of male and female, masculine and feminine as designed by the one who created those realities himself.

Turning these foundational principles into practical legislative realities will take conviction, perseverance, and prayer, but it is the duty of those in authority to pursue these things not only in alignment with basic reason, but in recognition of the transcendent authority who has delegated his power for a short time for the general flourishing of his image-bearers.

The first step in that mission of promoting the common good of all within this state can only be to recognize that which God in his good providence has designed as a fixed reality: male and female. Without a proper understanding of these previously-obvious distinctions, we cannot possibly hope to leave our children and grandchildren a better society than the one we inherited from our parents and grandparents.

Below you will see a few of the key pro-family policies that The Family Foundation believes the Commonwealth can move forward in this mission during the upcoming legislative session. As we quickly approach the start of the 2025 General Assembly on January 7, we encourage you to reach out to your legislators and local officials and express your desire that they stand for these important policies. Above all, keep standing strong for truth, and keep fighting the good fight!

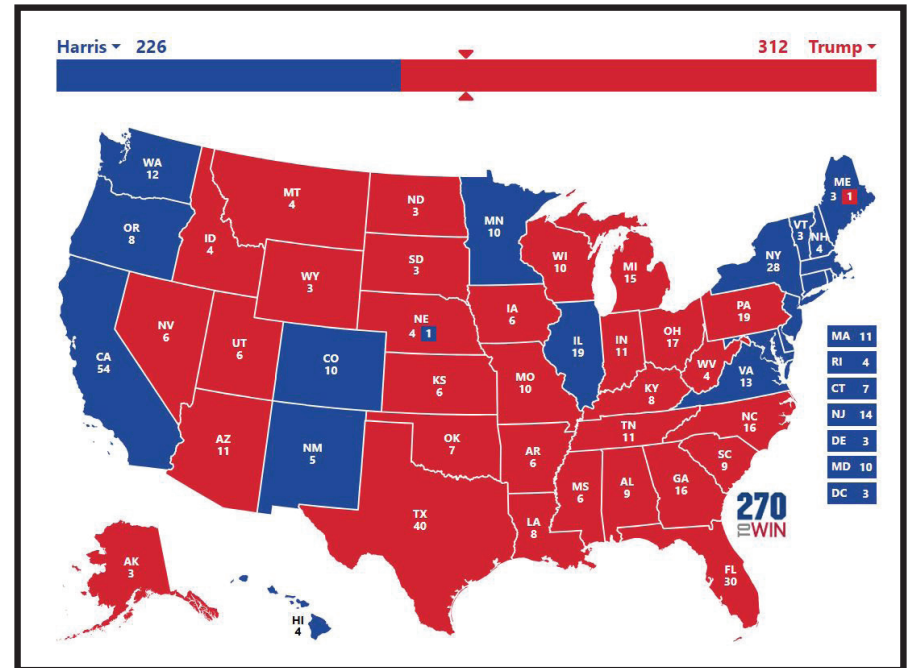
Republican trifecta: GOP gains control of White House and Congress.

Trump's legislative agenda likely to have fewer roadblocks with the balance of power now squarely in Republican hands.

On November 5th, a political earthquake shook Washington, D.C. As the results started to come in from across the nation, it became clear that the American people have had enough of Democrat control. What began (presumably) as a 50/50 race eventually became a convincing victory for President-elect Donald Trump, a sizable Republican majority in the Senate, and a continued GOP majority in the House.

As of this writing, there are still some undecided House races, but we know enough to say that Republicans will be in a position to enact much of their legislative agenda with little meaningful resistance. Only time will tell whether they remain firm on guiding conservative principles, but it is certainly our prayer that they will make considerable progress at stemming the tide of cultural destruction, which accelerated under the Biden/Harris administration.

As we approach the 20th of January, President-elect Trump will continue making selections for cabinet positions, the legislative agenda will begin to take shape, and foreign policy priorities will become clear. Each of these things has the ability to profoundly impact the lives of every American not only for the next four years, but for generations to come. For our part, social conservatives must continue to speak up and speak out about the importance of confronting cultural issues with biblical values. Only Christ working in us and through us can transform that which is dead and broken. We pray that there will be a revival among our leaders, that they will be powerful instruments for the Kingdom, and that they will pursue goodness, punish evil, and give glory to God in all that they do.



Abortion on the ballot: key victories and setbacks.

Results continue to show Dobbs was not the end of the pro-life fight but only the beginning of a larger battle.

Voters in ten states had abortion directly on their general election ballots this November. Those states were Arizona, Colorado, Florida, Maryland, Missouri, Montana, Nebraska, New York, Nevada, and South Dakota. While the language of those abortion initiatives varied by state, the goal in each case was the same: the enshrinement of the false “right” to murder the preborn up to the moment of birth in each state’s constitution. In Nebraska, pro-life organizations fought back and put a competing abortion ban on the ballot.

Voters in three of those states (Florida, Nebraska, and South Dakota) defeated the efforts to legalize abortion in their state constitutions. As a result, the pro-life laws in each state will remain in effect. These results were the first pro-life victories in abortion votes since the Supreme Court overturned *Roe v Wade*. The victory in Florida, which is the third largest state in the U.S., is especially important. If Florida had legalized abortion up until birth, it would have become one of the largest abortion destinations in the country. We are thankful for Governor Ron DeSantis’s effective leadership in defeating that

amendment and for his strong advocacy in support of pro-life laws in Florida. In Nebraska, voters went a step further and put a ban on abortion after the first trimester (12 weeks) in the state constitution. These victories give the pro-life side momentum to fight against future attempts to legalize the murder of the preborn around the country.



Unfortunately, the other seven states voted in favor of their abortion initiatives. The most disappointing of these states is Missouri, which had a total ban on abortion up to this point. With their election results finalized, it will only be a matter of time before a lawsuit results in Missouri courts overturning that ban. These results show that those of us on the pro-life side have a long way to go to ensure that our culture and laws respect the right to life of every human being, regardless of age or size. Please continue to pray that our leaders and society will recognize the dignity of human life and encourage your church leaders to engage on this important issue. The church will be essential in ensuring that our culture moves in a pro-life direction.

WAKING UP TO THE NEW FRONTIER OF PARENTING: PROTECTING KIDS ONLINE

THE THREAT OF THE LGBTQ REVOLUTION ON RELIGIOUS LIBERTY IN AMERICA

Jay Richards (The Heritage Foundation) shared some of his research on the progression of the LGBTQ revolution and its societal harms, Greg Chafuen (Alliance Defending Freedom) spoke about the ongoing efforts to protect Christian businesses, doctors, counselors, and other professionals from government efforts to suppress their religious practices and free speech, and Joseph Kohm (Family Policy Alliance) spoke on the importance of legislation to protect the conscience of individuals faced with these unbiblical forms of sexual expression.

One issue the panelists discussed was Governor Beshear's unlawful executive order banning so-called "conversion therapy." This order threatens counselors who use Christian teachings in their practices. Reversing this order will be a top priority for The Family Foundation next legislative session, and we will also work with allies to support a legal challenge to invalidate the governor's actions.

KEYNOTE ADDRESS: DR. GEORGE BARNA

Dr. George Barna (Professor at Arizona Christian University & senior fellow at Family Research Council) shared his research on the importance of discipling individuals in the church to develop a strong biblical worldview. This is especially important when raising young children, and Barna encouraged attendees to be unwavering in their commitment to not just evangelize, but to also intentionally disciple those that they know.

Addia Wuchner (KY Right to Life) and Sue Swayze Liebel (Susan B. Bunni Pounds (Christians Engaged) spoke about the need to get the Church involved in our electoral system.

Panelists shared that they are optimistic about the future, but that there is still much to be done. From getting a larger share of Christians to the polls, to remaining steadfast in the face of pro-abortion attacks, the church is under great pressure. However, with the power of the Spirit, and the Word of Christ, we can be confident that God is in control and that His will is ultimately going to come to pass.

AMENDMENT 2 AND THE FUTURE OF EDUCATIONAL FREEDOM IN KENTUCKY

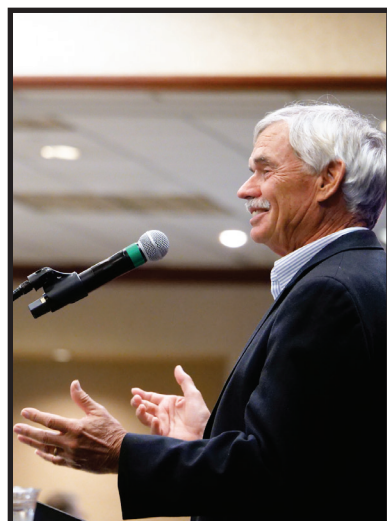
Sen. Lindsey Tichenor, Jim Waters (Bluegrass Institute), and Jesse Green (The Family Foundation) spoke about why Christians need to support Amendment 2, Kentucky's school choice amendment on the November ballot. Sen. Tichenor spoke about the school her church recently started. Jim Waters spoke about the data from surrounding states that supports school choice policies. And Jesse Green spoke about his own experience with private schooling and why all Kentucky families deserve those same opportunities.

David Walls (The Family Foundation) facilitated the discussion with questions about the attacks on Christian values in some public schools, including a personal example from when his son's public school tried to bring Planned Parenthood's sex education curriculum into elementary school education.

Unfortunately, Kentucky voters did not vote to ratify Amendment 2, leaving the government education monopoly in place for the time being. Despite this setback, The Family Foundation still supports school choice and other policies that empower parents in education. Kentucky's one-size-fits-all education system is harmful to children and families and must be reformed.

INAUGURAL FOUNDER'S AWARD RECIPIENT PASTOR KENNY DAVIS

The 2024 Founder's Award is The Family Foundation's inaugural award in honor of our founder and former executive director, Kent Ostrander, who was also honored at the event. The award is given to a leader in Kentucky who has exhibited God-honoring leadership for Kentucky families and the biblical values that make them strong.

Pastor Kenny Davis served as the Pastor of Bethel Baptist Church in Berea for 24 years. He has been a strong advocate and voice for the unborn, has preached in crusades in Botswana, ministered during hurricane relief efforts, and taken numerous mission trips to Panama. Pastor Davis has been a strong ally of The Family Foundation in our effort to ensure that Kentucky's institutions and public policy reflect the Christian values that our country was founded on and that make our country strong.

Kentucky voters give general assembly mandate to enact pro-family policies.

Legislators should capitalize on decisive pro-family majorities in both chambers during 2025 legislative session.

President-elect Trump's popularity in Kentucky delivered him a 30-point victory for Kentucky's eight electoral votes. However, his impact on Kentucky did not stop there. His results at the top of the ticket trickled down to the General Assembly, where Republicans maintained their supermajorities in both legislative chambers. These electoral results further emphasize the voters' rejection of far-left ideologies, like gender ideology and DEI.

In the State House, Republicans maintained their 80-20 supermajority, though two seats did switch partisan hands. Republican Vanessa Grossl defeated Democrat Rep. Cherlynn Stevenson in the 88th district, flipping that seat to the Republicans. On the other side of the partisan divide, Democrat Adam Moore defeated Republican Thomas Jefferson in the 45th district, flipping the seat to the Democrats. Jefferson previously defeated Republican Rep. Killian Timoney, the lowest scoring Republican on our TFFKY legislative scorecard, in the May primary election. Notably, Jefferson was the subject of several misleading attacks from the pro-gambling crowd in the lead up to the election. Meanwhile, the Republican Party of Kentucky provided zero assistance to Jefferson's campaign during this close race.

One of the most exciting additions to the House Republican Caucus is TJ Roberts. Representative-elect Roberts is an attorney in northern KY. He notably made national news when he challenged Beshear's church ban in court during the 2020 lockdowns. Roberts also has a history of lobbying for pro-family legislation, like Kentucky's Campus Free Speech Act, and will be taking over for pro-family Rep. Steve Rawlings, who scored a 100% on our TFFKY legislative scorecard. When we asked Roberts what he is most looking forward to in the House, he stated, "I look forward to fighting for the faith, family, and freedoms of people in Kentucky." Roberts also stated that his top three priorities for this session are a taxpayer Bill of Rights, expanding Kentucky's anti-corruption laws, and strengthening protections for civil liberties,

especially religious liberty. We look forward to working with Rep. Roberts to enact strong pro-family policies.

In the State Senate, Republicans maintained their 31-7 supermajority. Unlike in the House, there were no seat changes. Two of the notable new members of the Senate Republican Caucus are Steve Rawlings and Aaron Reed. Senator-elect Rawlings previously served in the House. He is taking over for pro-family Sen. John Schickel, who is retiring after a long career of

public service. Senator-elect Reed is a veteran and gun shop owner. He is taking over for pro-family Sen. Adrienne Southworth. When asked about his legislative priorities, Rawlings listed "protecting religious liberty and medical conscious rights, fighting back against overreach from the federal government, and supporting certificate of need reform to ensure citizens have adequate access to healthcare services." We look forward to working with Sen. Rawlings and Sen. Reed to enact strong pro-family policies.

Despite Trump's success in Kentucky, not all elections had pro-family results. Liberal Judge Pamala Goodwine overwhelmingly won her race for the Kentucky Supreme Court against conservative Erin Izzo. Based on the outcome of this race, the far-left ACLU has already filed a pro-abortion lawsuit against Kentucky's pro-life laws (*see below*).

Additionally, Amendment 2 failed to reach the necessary majority for ratification by the voters. This defeat comes after public school administrators spread false information about Amendment 2 and blatantly broke the law by using taxpayer resources to campaign against the amendment. Despite this disappointing result, The Family Foundation remains committed to fighting for greater educational opportunities for Kentucky families and students. Kentucky's one-size-fits-all education system is failing many students and families, and an essential part of improving our education system is by providing increased freedom and choice for Kentuckians.

ACLU attacks preborn Kentuckians in new lawsuit.

Jefferson County resident sues for the right of mothers to kill the unborn and overturn Kentucky's strong pro-life laws.

As mentioned above, the ACLU recently filed a class action lawsuit against Kentucky's pro-life laws on behalf of Mary Poe, a resident of Jefferson County who chose to be identified under a pseudonym. Poe is seeking to overturn Kentucky's abortion restrictions, claiming the Kentucky Constitution contains a hidden right to kill a preborn child that should overturn Kentucky's duly-enacted pro-life laws. She is also claiming to represent a class of persons, which includes all current or future pregnant women living in the Commonwealth.

The Family Foundation and pro-life allies attended an initial hearing held in Jefferson County Circuit Court on November 18th where Judge Tracy Davis heard motions from the ACLU related to certifying the class that Poe claims to represent. Upon pushback from the Attorney General's office, the judge de-

layed ruling on class certification until at least early-January of 2025. This delay keeps Kentucky's current pro-life laws in place pending further proceedings. Despite the delays in the case, the ACLU broke the dreadful news that Mary Poe had traveled out-of-state to kill her unborn child, Baby Poe, just a few days after filing the lawsuit.

The Family Foundation will continue to follow the important updates in this case along with our ally, Kentucky Right to Life. In the meantime, we encourage our supporters to be in prayer for the Attorney General's office that they would strongly defend Kentucky's laws, that the judge would rule in this case righteously, and that Mary Poe would be convicted of her sin, turn to Christ, and drop her lawsuit.

TFF files U.S. Supreme Court briefs in major cases.

Kentucky's Help Not Harm (SB 150) and Online Age Verification (HB 278) laws at stake in major cases at the High Court.

As we covered in our last edition of the Citizen, the U.S. Supreme Court is considering important cases this term that will certainly impact pro-family laws around the country. In *United States v Skremetti*, the Court will consider whether laws that ban gender “transition” procedures for minors violate the 14th Amendment’s Equal Protection Clause. The Supreme Court heard oral arguments in *Skremetti* on December 4, 2024. In *Free Speech Coalition v Paxton*, the Court will consider whether age verification laws that prohibit minors from accessing adult websites violate the 1st Amendment’s free speech protections. The Supreme Court has set *Free Speech Coalition* oral arguments for January 15, 2025. In both cases, The Family Foundation joined amicus (“friend of the court”) briefs asking the Supreme Court to uphold both pro-family laws. While Kentucky laws are not directly involved in either case, Kentucky’s laws will be impacted by what the Supreme Court decides in both cases.

For the *Skremetti* case, The Family Foundation joined the amicus brief filed by The Family Action Council of Tennessee in support of Tennessee’s ban on “transition” operations for minors. This brief argues that the Court should not give special weight to the opinions of medical “experts” when determining legal principles. “[The] Court should refuse the incredible suggestion that the life or biological sciences answers the legal question before it, and thus removes from consideration those matters of human nature that have ever and always informed, and inescapably been implicated in, legal and constitutional determinations.” The Supreme Court must decide based on long-held legal principles, not distracting arguments from medical organizations that have little constitutional law experience and that profit off these barbaric operations.

The brief also argues that states have the constitutional power to regulate dangerous medical practices. “As persons have a right not to be bodily injured by third persons, physicians like all other third persons have a corresponding duty in their practice not to injure the bodies of the persons who are their patients. The jurisdiction of States to regulate the practice of medicine to protect the health of its citizens has been recognized since adoption of the Fourteenth Amendment.” We continue to pray that the Supreme Court embraces truth and properly upholds the ability of states to ban harmful gender “transition” procedures for children.

For the *Free Speech Coalition* case, The Family Foundation joined an amicus brief filed by the Minnesota Family Council, Kansas Family Values, Texas Values, and 30 state family policy organizations in support of Texas’s age verification law. The brief starts out by highlighting the significant impact that pornography has on young children and their ability to properly form healthy romantic attachments. “Much like tobacco or other controlled products, pornography’s impacts are even more harmful to young minds due to its addictive nature, and access to it should be properly age gated. The material that is available online today far exceeds what was available in magazines or movies in prior generations. As such, its effects on children are especially poignant, as this content is exceedingly harmful to their ability to form healthy romantic relationships as adults and their ability to function well in society as they mature into adulthood.” Pornography is a destructive force in society. We must protect children from its devastating scourge on their lives.

The brief concludes by arguing that the Constitution gives state legislatures the authority to regulate activities that harm children, even if they have limited authority to regulate those activities when adults seek to participate in them. “[The] Court has recognized that children have limited decision making capacity and sometimes legislatures need to step in to protect them. ‘The State commonly protects its youth from adverse governmental action and from their own immaturity by requiring parental consent to or involvement in important decisions by minors.’ Under the law, our society has recognized that children’s capacity is limited both neurologically and in maturity. Because of these limitations, legislatures are well within their authority to place boundaries on children that in some circumstances would not be permissible if applied to adults.” Age verification laws are a proper use of legislative power to protect children without overly burdening activities of adults. We pray the Supreme Court will uphold these commonsense protections.

These next months will be crucial for the future of pro-family laws around the country, including similar laws passed in Kentucky with the support of The Family Foundation. After the Supreme Court hears oral argument on these cases, its members will spend the Spring debating whether these laws pass constitutional muster or not. Please pray that the Justices do their due diligence and realize that the Constitution gives state legislatures the power to protect kids from harmful transgender operations and pornographic materials.
